Agency Enabled Retail Rescue Pick-ups

To help us keep accurate record of the pounds of food being rescued during pick-ups, please remember to submit your receipts on a weekly basis so it is not a chore to do at the end of the month. Cultural Foods

Over the last year the Ending Hunger 2.0 team has held focus groups and surveys with the New American, Foreign Born and Immigrant communities to learn more about their food preferences. From these focus groups, we have created food lists for different communities (Somalian, Afghan, Kurdish, South Sudanese, Liberian, Hispanic, Bhutanese, and Congolese). Starting this fall you will start to see products on the order sheet that are referred to and labeled as Cultural Foods. These are for pantries/ meal sites that are serving our New American, Foreign Born and Immigrant communities.

Please be mindful when adding to your cart- if you are not serving these communities please do not take these products. There will also be limits on these items so that more partners can access them. We would love your feedback about the products.

An example is: if there is Halal Goat Meat, this is specific to the Muslim community, they cannot eat other types of meat if it is not Halal. So unless you are serving Muslim community members please do not take to give to the general public as they can eat other types of meat.
